## COURSE DESCRIPTIONS

### *Training Courses*

---

#### Basic Life Support CPR (AHA) Normal Operations (4 Hours)

The Basic Life Support CPR for Healthcare Providers Course is designed to provide a wide variety of healthcare professionals the ability to recognize several life-threatening emergencies, relieve choking in a safe and timely manner, and provide CPR certification.

#### Basic Life Support CPR (AHA) Pandemic Operations (4 Hours)

The Basic Life Support (BLS) for Healthcare Providers Course is designed to provide a wide variety of healthcare professionals the ability to recognize several life-threatening emergencies, relieve choking in a safe and timely manner, and provide CPR certification.

#### NREMT EMT Basic Refresher (40 Hours)

The 40-hour EMT-Refresher course is a review of the skills and knowledge covered in the EMT- Basic course. Attendance in an EMT-Refresher course and successful completion of practical testing every two years is required by the National Registry of Emergency Medical Technicians to maintain EMT certification.

#### NREMT Paramedic Refresher (45 Hours)

The Paramedic five-day Refresher course provides the student with the Mandatory and Flexible Core requirements of the National Registry of Emergency Medical Technicians Paramedic Refresher content and the U.S. Department of Transportation Paramedic Refresher Curriculum. This program utilizes a combination of directed study, classroom lecture, practical skills practice, and simulated patient scenarios to refresh the pre-existing knowledge base and skills of an EMT-Paramedic.

#### NREMT Paramedic Refresher (24 Hours)

The Paramedic 3-day Refresher course provides the student with the Mandatory and Flexible Core requirements of the National Registry of Emergency Medical Technicians Paramedic Refresher content and the U.S. Department of Transportation Paramedic Refresher Curriculum.

#### Active Shooter / Armed Intruder Response (8 Hours)

The Federal Strategies Active Shooter/Armed Intruder Response Training has been received and validated by military and civilians deployed worldwide. Instruction will include introducing students to vivid scenarios that demonstrate situational awareness, ability to identify pre-incident indicators and physical countermeasures. Students will be taught mindset and methods to enhance their speed of recognition and speed of response to identifiable threats as well as understanding and mitigating the physiological effects of threats.

#### Technical Site Security Survey (8 Hours)

In our assessments we will measure “what is” against “what should be”, in order to protect assets by limiting exposure. Our assessments approach will be rational and orderly thus providing comprehensive solutions to problem identification and probability determinations. We will specifically identify assets in need of protection, exposures, and tailored made solutions/training package for each facility. Our approach will be to use the assessment as a management tool to identify vulnerabilities that could conceivably be exploited by a

threat such as an Active Shooter/Armed Intruder. Assessments will be conducted hand-in-hand with facility managers. For buildings where the client is a tenant, our staff will coordinate with the building owner/manager in order to schedule the required facility survey. Our finding and procedures will be presented to the client and/or other designated staff for review. The assessment will identify facility factors favorable to response options. Combining our documented assessment procedures with education and training we will assist managers and staff to limit exposure to risks and threats.

### Tactical Pistol 1 (24 Hours)

This course focuses on safe weapons manipulation, cognitive processing, efficient body mechanics and ergonomics as they relate to tactical pistol and engagement. Topics covered include: Firearm safety, nomenclature, equipment options, weapons handling, principles and fundamentals of responding to threats, target engagement and responding to threats.

### Tactical Pistol 2 (24 Hours)

This course is designed for the formally trained shooter with experience safely and consistently utilizing pistols in a tactical manner. This course will focus on establishing and refining efficiencies and consistencies of tactical critical threat response with pistols. Topics covered include: Firearm safety, equipment and carry options, threat discrimination, shooting with movement and communication, small team tactics, multiple target engagements, third-party protection, unconventional firing positions, low light engagement and stress inoculation threat response challenges.

### Tactical Carbine 1 (24 Hours)

This course focuses on safe weapons manipulation, cognitive processing, efficient body mechanics and ergonomics as they relate to employing the carbine in a tactical manner. Topics covered include Firearm safety, nomenclature, equipment options, weapons handling, principles and fundamentals of responding to threats, target engagement and responding to threats.

### Tactical Carbine 2 (24 Hours)

This course is designed for the formally trained shooter with experience safely and consistently employing carbines and rifles in a tactical manner. This course will focus on establishing and refining efficiencies and consistencies of tactical critical threat response with a carbine. Topics covered include Firearm safety, equipment and carry options, threat discrimination, shooting with movement and communication, small team tactics, multiple target engagements, third-party protection, unconventional firing positions, low light engagement and stress inoculation threat response challenges.

### Krav Maga Training

Krav Maga is a self-protection fighting system of Israeli origin. Krav Maga is not a sport or traditional martial system but a system incorporating refined techniques and tactics familiar to many martial systems. The techniques of Krav Maga are based on principles and fundamental movements applicable to servicing threats in varying conditions and circumstances. The techniques and tactics of Krav Maga are designed generally for close quarter, possibly life-threatening situations. The guiding principle of Krav Maga is to service the threat, counterattack for self-protection purposes and escape. Working with the client, the Krav Maga course of instruction is intended to be tailored specifically to the client's needs.
